
#### **Conclusion**

### Report of the Anti-ragging Cell (2020-21)

Sree Narayana College, Chengannur, strictly adhered to the guidelines laid down by Hon'ble Supreme Court of India which has banned ragging in all institutions of higher education. In pursuance of its significant judgment dated 8 May 2009 in Civil Appeal No. 887/2009 which was notified by UGC as 'Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009' and subsequent communications received from the Ministry of Human Resource and Development from time to time, relevant steps were taken to curb, prevent and eliminate the menace of ragging.

These steps include:

#### **1. Existence of Anti-ragging Cell:**

The Anti-ragging Cell/Committee of the college that looks into, controls and prevents the incidents of ragging in the college, if any, comprises of the following members:

#### **2. Display of Names and Phone Numbers:**

The names and phone numbers of the members of the Anti-ragging Cell were displayed prominently on hoardings installed at important spots in the college to enable students to approach them for help promptly.

#### **3. Information on Institutional Website:**

To curb the menace of ragging in college the contact details were uploaded on the institutional website for the information of the students and their parents:



#### **4. Anti-ragging Warning in the Institutional Handbook:**

The statutory warning against Ragging was printed for the information of students as well as their parents.

#### **5. Anti-ragging Undertaking**

As per the instructions of the government, Anti-ragging Undertakings were sought from all students at the time of admission. The submission of the document ensures the students' commitment of compliance with the government's policy of eradicating ragging.

#### **6. Display of Posters:**

Colourful and thought-provoking Posters regarding the menace of Ragging are displayed at various places within the college campus and hostel to warn and sensitize the students about this evil.

#### **7. Introduction of the freshers with the Committee:**

During the Induction/Orientation Programme held in the online mode during the Covid-19 Pandemic, the Convener and members of the Anti-ragging Cell were introduced to the new students.

#### **8. Allotment of Mentors:**

All the students enrolled in the college were divided into small groups and assigned a Mentor even in this Pandemic-ridden session. These could easily be approached for any assistance or guidance through phone, Whatsapp or in the Google Classroom.

#### **9. Student Grievance Redressal Cell:**

The college has an active Student Grievance Redressal Cell which can also be easily approached in case of need. The names and phone numbers of the Committee were displayed prominently within the campus as well as the institutional website.


#### **10. Access to Principal:**


**Measures Taken**


