Sanction has therefore been accorded by the Joint Registrar (Exams II) to the candidates noted above (2020-2021 admission) who are appearing for the First Semester BA/ B.Sc/B.Com/B.Voc degree examinations September 2021 being granted the following special concessions.

(a) As per the provision the candidates with benchmark disability (40% and above) are granted the service of a scribe for the first semester University examinations onwards. The Principal/Chief Superintendent is authorised to appoint a suitable scribe for the candidates who shall neither be an employee of the college nor one who is interested in the candidate. Special care shall be taken to ensure that the scribe appointed does not have educational qualification higher than that of the candidates. The remuneration to the scribe shall be paid by the Principal/Chief Superintendent at the rate of Rs.250/- (Rupees Two Hundred and Fifty only) per paper after claiming the amount in separate bills immediately after the examination as per UO read (1) above.

(b) The above noted candidates are being granted compensatory time of 20 minutes per hour for answering each paper.

(c) They are also being granted grace marks of 25% of the total marks in theory examinations provided the candidates secure a minimum of 10% in the theory examinations as they are backward in language ability subject to the condition limited to attain a maximum of 60% marks for each subject i.e., the total of ESA marks and the grace marks should not exceed 60% of the total ESA marks of the subject from first semester onwards.

The candidates shall be eligible for the above mentioned benefits for all the examinations whether regular or supplementary, taken within the period of above course, provided he/she pursues the course without any break, and the disability is of a permanent nature. Separate orders necessary for each examination after the course period.
